| <b>General eligibility criteria</b>  | <p>To be eligible for associate membership you must comply with the following:</p> <ul style="list-style-type: none"> <li>- Registered not-for-profit or charitable group or entity in NSW;</li> <li>- Transport heritage focussed – ideally rail, tram, bus, or ferry;</li> <li>- Purpose or objects relate to the restoration, maintenance and preservation of transport heritage assets and artefacts;</li> <li>- Membership – open to (private) individuals from the general public without limitation;</li> <li>- Volunteer-based – operations, regular activities and events;</li> <li>- Site and/or other activities - regularly open/available to the general public;</li> <li>- Commercial activities (with For-profit entities) – allowable, however should be less than 50% of annual turnover;</li> <li>- Constitution – provides for distribution of assets to like organisations in the event of wind-up, i.e., keep the transport heritage assets in the transport heritage sector.</li> </ul> |
