VOTING MEMBERS

Members are reminded that to be eligible to vote at the AGM you must be at least 18 years of age and a current financial member as at midnight Tuesday 30 September 2025.

ELECTION OF DIRECTORS

An election of two (2) Elected Directors is required in 2025 and there are four (4) candidates for election, hence a ballot is required.

All nominations were received by the closing date on 18 September 2025, checked in accordance with Clauses 18 and 20 of the Constitution and were deemed to have met the requirements.

QUESTIONS ON NOTICE

Questions on notice from members must be addressed to the Volunteer Company Secretary via email only at agm@thnsw.com.au and received no later than 5:00pm (AEDT) Sunday 2 November 2025.

Questions on notice should be:

- courteous and respectful
- related directly to the matters of the AGM and preferably the year in review
- clear, concise and to the point, and
- preferably limited to no more than three questions from any one individual member to give reasonable opportunity for more members to ask questions.

Similar questions from one or more members may be grouped together and a single response provided. Questions that have been asked before and responded to during previous AGMs will not be readdressed unless something has changed significantly.

The Board will determine the form of any responses to questions on notice. This may include responses directly to the member outside of the AGM if the matter is more relevant to the individual or a small number of members rather than the membership as a whole. Prior to the AGM, the Board via the Volunteer Company Secretary may ask a member to clarify their question if it is not sufficiently clear.

It may not be possible to answer all questions during the AGM such as those requiring detailed analysis or research. Such questions will be acknowledged and deferred if there is insufficient time to prepare a response.
